## **Privacy Policy KOTRA 2025**

## 1.1 - How we use your personal data

When you register you will participate in the event. KOTRA Amsterdam will collect and store your personal data in order to manage your participation in the event. Participating companies might receive your personal data if you acquire a one-on-one meeting. For further information on how we use your personal data, your rights as a data subject or how to contact our data protection officer, please refer to the contact information at the end of this document.

# 1.2 Your consent to the processing of personal data

I acknowledge that KOTRA is a public agency by the State of South Korea. Their events are funded with public funds of the State of South Korea and KOTRA enables my participation in the event free of charge. In return, I provide my personal data to KOTRA also for the above-mentioned purposes. You can withdraw your consent to the processing of personal data any time, without affecting the lawfulness of processing based on consent before its withdrawal. If you object, only the usual transmission costs according to the basic tariffs are incurred. Please note that in case of your withdrawal we might not be able to enable your participation in the respective exhibition or parts of it. The processing according to other legal bases (e.g. based on the legitimate interest of KOTRA) remains reserved.

With registering and sending this application form to KOTRA I consent to the processing of my personal data by KOTRA Amsterdam, KOTRA European Head Office (Frankfurt / Germany) and KOTRA Headquarter (Seoul / Korea) for analysis and administrative reporting purposes, as well as evaluating possible business opportunities and transferring your data to potential Korean business partners, each as set forth in the consent as contained in section 3.1 of the Privacy Policy.

To the extent that we are processing your personal information based on your consent, you have the right to withdraw your consent at any time. You can do this by contacting us using the details in the contact section on the last page of this document.

#### 2 - What are your rights

- 1. According to article 17 in the EU GDPR, you have the right to be "forgotten", this means that you got the right to ask for the deletion of all your personal information that we have stored at any time.
- 2. You got the right to ask us to give you a copy of all the information that we are holding regarding you. Where we have good reason, and if the GDPR permits, we can refuse your request for a copy of your personal information, or certain elements of the request. If we refuse your request or any element of it, we will provide you with our reasons for doing so.
- 3. You got the right to contact us to change details of the information on your Curriculum Vitae if it has become outdated or is incorrect. Please look at our contact information section in the last page of this document.

### 3 - What information are we keeping

- 2. Your email is also being stored.

## 4 - How we are using your information

- 1. Your CV is stored in KOTRA for the purpose of the process of matching you with your potential job interview.
- 2. Your email is stored so KOTRA can remain in contact with you, during the event, and after the event. We shall keep your information until you find a suitable job, or until you tell us to delete your details.
- 3. Participating companies might receive your personal data if you acquire a one-on-one meeting.

## 5 - How we are keeping your information secure

### 6 - How long are we keeping your data

- 1. KOTRA has the right to store your data until it is no longer necessary.
- 2. The companies that are attending the career event can store your information, if they see a future opportunity for you.

### 7 - How we share your personal information

1. In certain circumstances we will share your personal information with other parties. Details of those parties are set out below along with reasons for sharing it. We disclose your personal information to clients who have vacancies for jobs in which you are interested.

#### 8 - Do we share your information with third parties outside the EU?

1. If not stated differently, we transfer your data to third parties' locations outside of the European Union as follows: We might transfer some of your personal data to our headquarter located in Seoul, Korea or to other KOTRA branches as far as this is necessary to fulfill our legitimate interests such as analyzing and identifying potential to enhance our processes and administering our systems. In case that these reports include personal data, this is usually based on your prior consent.
